# ARTICLES OF INCORPORATION OF

# CANARSIE, INC.

The undersigned hereby subscribes to these Articles of Incorporation for the purpose of becoming a corporation under the laws of the state of Florida, by and under the provisions of the statutes of the state of Florida, providing for the formation and liabilities, rights, privileges, powers and immunities of a corporation for profit, and I hereby certify:

## ARTICLE I

The name of this corporation is CANARSIE, INC.

## ARTICLE II

This corporation is organized for the purpose of the restaurant business, and any and all other kinds of related incidental activities thereto, without limitation and for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes viz:
