ARTICLE I

The name of the corporation is F.J. ALVARADO, CORP.

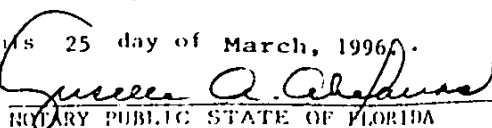

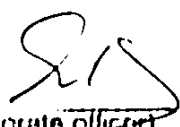

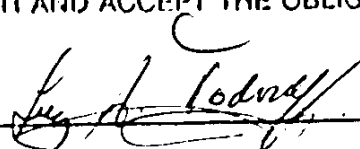
