ARTICLES OF INCORPORATION

OF

TOM MITCHELL INCORPORATED



THE UNDERSIGNED, subscribed to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE 1

The name of the corporation shall be:

TOM MITCHELL INCORPORATED

and its initial post office address and its principal office for the conduct of business is:

14741 Cedar Creek Place, Davie, FL 33325

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE II

The general purpose of the corporation is to engage in any activities or businesses permitted under the laws of the United States and Florida, including, but not limited to, the operation and management of a commercial and residential locksmith company.

ARTICLE III

The term for which this corporation shall exist shall be perpetual and the business of the corporation shall be conducted, carried on and managed by the officers of this corporation and

a Board of Directors composed of one or more members, which number may be altered from time to time by an amendment to the By-Laws of this corporation within the lin/itations prescribed by law

The officers of this corporation shall be a President, Vice President, Secretary and Treasurer, and any other officer as the Board of Directors may deem expedient, one or more of which may be designated in the name of the same person

The corporation shall indemnify any officer or director, or say former officer or director, to the full extent permitted by law.

These Articles of Incorporation of this corporation may be amended, changed, altered or repealed in the manner now or hereafter prescribed by the Florida Statutes and all rights conferred upon stockholders herein are granted subject to this reservation.

The shareholders and directors of this corporation may take action by written consent, as provided by law.


