### ARTICLES OF AMENDMENT

for

#### HAYMAN-WOODWARD HOLDINGS, INC.

In accordance with shareholders' approval of a proposal to amend the Company's Articles of Incorporation to increase the number of authorized shares of the Company's common stock, no par value, from 1,000 shares to 2,000 shares duly executed by a majority of the votes cast by the shareholders of Hayman-Woodward Holdings. Inc. entitled to vote thereon, and ratification of such action by the Company's Board of Directors, the Company's Articles of Incorporation are hereby amended as follows:

**Article 5.** The number of shares of capital stock that this corporation is authorized to have outstanding at any one time is 2,000 shares, no par value.

Except as amended above, the remainder of the Company's Articles of Incorporation shall remain unchanged, and are hereby ratified and confirmed.

The foregoing Amendment to the Articles of Incorporation was duly adopted on December 27, 2018 by a majority vote of the holders of the Corporation's common stock, no par value, no Preferred Shares being outstanding, and approved by a sufficient number of votes pursuant to the Florida Statutes.
