The uncersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, horeby forms a Corporation under the Laws of the State of Florida.

### ARTICLE I

# NAME. ADDRESS AND INITIAL REGISTERED AGENT AND OFFICE
