its or his opinion such director or officer was not guilly of arons negligence or willful mytsconduct in the performance of his duty, and in the event of a settlement, that such settlement wass or is in the best interest of the corporation. If this determination is to be made by the Boaard of Directors, it may rely as to all questions of law on he advice of independent counsel. Such right of indemnification shall not be deemed exclusive of any rights to which be may be entitled under any bylaw, agreement vote of stockholders, or otherwise.
