The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is YKP ENTERPRISES, INC.

ARTICLE TWO
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE
PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To be a general partner of a limited partnership to be established for the purpose of patenting, developing and marketing a particular product.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other business in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or desirable in order to accomplish the foregoing.

ARTICLE FOUR
CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shares shall be of a single class and shall have a par value of Ten Dollars (\$10.00) per share.


