ARTICLE I - NAME

The name and mailing address of Saaz, Fuggles & Goldings, Inc. is 2937 Biscayne Boulevard, Miami, Florida 33137.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on March 18, 1996.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

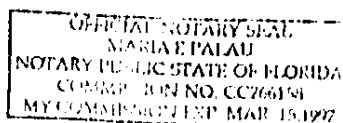
