#### Article VII - Directors

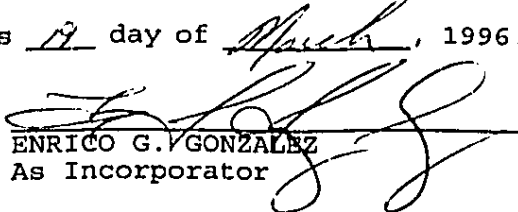
