The undersigned Incorporator, HOWARD A. BAKER, III, M. D., P. A., for the purpose of forming a professional corporation pursuant to the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME.**

The name of the corporation is Howard A. Baker, III, M. D., P. A. (the "Corporation").

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS.**

The address of the principal office of the Corporation is 3100 U.S. Highway 1 South, Suite 3, St. Augustine, Florida 32086. The mailing address of the Corporation is 3100 U.S. Highway 1 South, Suite 3, St. Augustine, Florida 32086.

**ARTICLE III. CAPITAL STOCK.**


**ARTICLE VII. PURPOSE.**

The Corporation shall have all of the rights and powers now or hereafter conferred on professional corporations by the laws of Florida.


