ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is J&G PAINTING AND DECORATING COMPANY, with its principal office and address being located at 6711 N.W. 24th Terrace, Ft. Lauderdale, FL 33309 and its mailing address being 6711 N.W. 24th Terrace, Ft. Lauderdale, FL 33309.

ARTICLE II - DURATION
