ARTICLES OF INCORPORATION OF

WE, THE UNDERSIGNED, HEREBY ASSOCIATE OURSELVES TOGETHER FOR THE PURPOSE OF BECOMING INCORPORATED UNDER THE LAWS OF THE STATE OF FLORIDA, UNDER THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE MARYANN K. BURKHARD, D.D.S., P.A.

ARTICLE II

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

THIS CORPORATION MAY ENGAGE IN THE FOLLOWING ACTIVITIES AND BUSINESSES:

A. TO PROVIDE PERIODONTAL SERVICE TO THE PUBLIC INCLUDING BUT NOT LIMITED TO, CLINICAL AND RADIOGRAPHIC EXAMINATION, DIAGNOSIS, PROGNOSIS, ESTABLISHMENT OF TREATMENT PLANS, AND MAINTENANCE CARE FOR INDIVIDUALS WITH PERIODONTAL NEEDS.

B. TO PROVIDE EDUCATION FOR THE PUBLIC IN THE CONTRIBUTING CAUSES FOR PERIODONTAL AND OTHER DENTAL DISEASES, THE MEANS IN WHICH AN INDIVIDUAL HAS TO CONTROL OR STOP REOCCURRENCE OF THESE DISEASES, AND THE INSTRUCTION OF DAILY HOME CARE TECHNIQUES.

C. TO PROVIDE AS INITIAL THERAPY, PERIODONTAL ROOT PLANING WITH OR WITHOUT LOCAL ANESTHESIA, OPTIONAL NITROUS OXIDE IN A SINGULAR OR A SERIES OF MULTIPLE APPOINTMENTS.

D. TO PROVIDE SURGICAL THERAPY UNDER LOCAL ANESTHESIA WITH OR WITHOUT NITROUS OXIDE SEDATION OR ORAL SEDATION MEDICATIONS OR IN CONJUNCTION WITH AN ORAL SURGEON WHEREBY CONSCIOUS SEDATION WILL BE ADMINISTERED.
