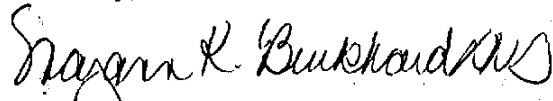
To Whom It May Concern:

I am in receipt of the attached notice. This is the second notice which also imposes additional penalties for the late filing for my professional corporation annual report. It was not my intention to not file or to be delinquent in sending in my report but my circumstances did not permit me the necessary awareness and organization to complete the proper return in the required time.

My husband, John F. Burkhard, a director of my corporation, handled all necessary paperwork for the corporation. Mr. Burkhard was diagnosed with Melanoma, the most fatalistic of all skin cancers, in July, 1996. In September, 1997, the melanoma had metastasized to his liver. I spent the majority of my time traveling from cancer center to cancer center with him searching for the best treatment. Unfortunately, the cancer claimed my husband on October 22, 1997. Due to the numbness I have been in after losing him, I have to admit the initial notice was misplaced or never made my desk. This is not the first detail I have missed, there have been numerous matters I am quickly learning about since Mr. Burkhard handled all these matters for me.

It is due to this fact that I ask you to abate the additional penalties that have been assessed. I know after this alarming notice, it will be one I now know will need to be done annually. Thank you in advance for your cooperation and consideration in this matter.
