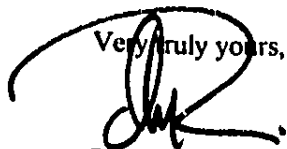

VI. REGISTERED OFFICE AND REGISTERED AGENT

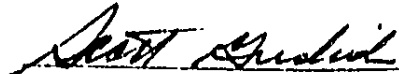
