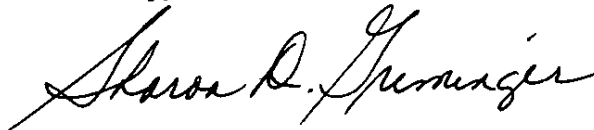

I recently became aware our corporation was no longer considered active. I did not receive the annual report notice in 2004, or any since. We have been filing our UTC-6 and carrying out business as usual. We moved twice since 2002 and probably this was the source of the error. I spoke to your office as soon as I noted the problem. They advised us to return the reinstatement form along with a check for \$450 (\$150/yr).
