CERTIFICATE OF INCORPORATION OF CV MASTERS, INC.



The undereigned hereby signs this Certificate of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I.

EFFECTIVE DATE

The name of the corporation shall be CY MASTERS, INC.

Ito mailing address shall be 2673 WEST 70 Place HIALEAH FLORIDA 33016.

Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.
