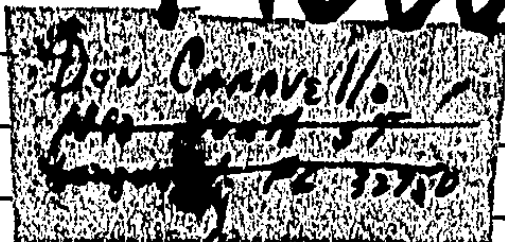


Dear Ms Baker:
