ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I  
NAME

The name of the Corporation is TYRONE SPORTS, INC.

ARTICLE II  
DURATION

The term of existence of the Corporation is perpetual, and the corporate existence will commence on the filing of these Articles of Incorporation by the Department of State.

ARTICLE III  
PURPOSE

The purpose of the Corporation is Retail and wholesale sales and consignment sales of new and used sporting goods and accessories, as well as all other lawful purposes permitted by the laws of the State of Florida.

ARTICLE IV  
CAPITAL STOCK

The aggregate number of shares that the Corporation has authority to issue is 7,500, all of which shall be common shares with a par value of \$1.00 per share.


ARTICLE V

INCORPORATOR


