ARTICLE I - NAME

The name of this corporation is KRISTA'S KASTLE, INC., with its principal office and address being located at 1111 Easton Road, Suite 27, Warrington, PA 18976, and its mailing address being 1111 Easton Road, Suite 27, Warrington, PA 18976.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

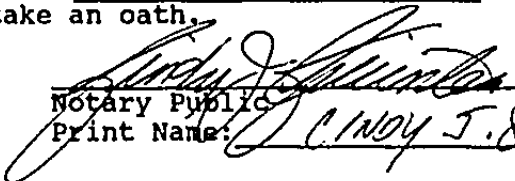
