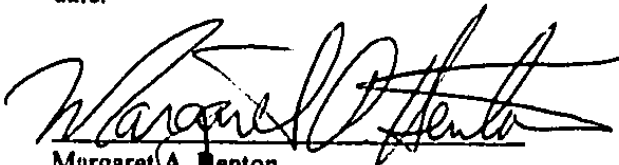

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopt the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Crystal Stair Productions, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 800 Virginia Avenue, Suite 2, Fort Pierce, FL 34982. The mailing address of the Corporation shall be 800 Virginia Avenue, Suite 2, Fort Pierce, FL 34982.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time, is one million (1,000,000) shares of common stock having a par value of one cent (\$0.01) per share.

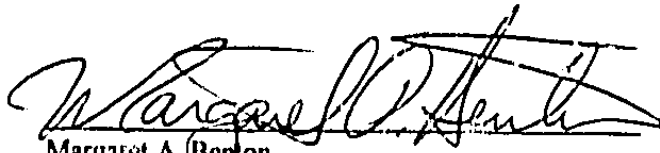
ARTICLE VIII - DATE OF EXISTENCE

ARTICLE IX - INDEMNIFICATION

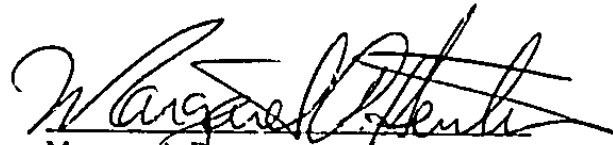
This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
