# Articles of Incorporation 96 MAR 22 AN IO: 33 CONSERVATIVE POWER ALLIAMER ASSEC, FLORIDA (CPA), INC.

#### ARTICLE I. CORPORATE NAME

The name of this corporation is: CONSERVATIVE POWER ALLIANCE (CPA), INC.

#### ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of providing economical effectuation for entities requiring necessary or desired levels of minority business opportunities, development and participation. aspects of ownership certification assistance, bonding All assistance, project development, contract compliance and monitoring assistance, community outreach and marketing assistance, business implementations designs/functions, training, administrative management consultants, construction, and other contractual related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida, shall be provided by this corporation. The corporation may further act as a holding company for similar types of entities that shall restrict subsidiary operations to certain geographical locations.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100,000,000 shares of common stock having par value of at least \$1.00 per share. Par value may be issued only for consideration having a value, in the judgment of the board of directors, at least equivalent to the full par value of the stock to be issued. No par shares may be issued only for such consideration as is determined by the board of directors. All shares issued shall be fully paid and nonassessable. A minimum of 51% ownership of any said shares being outstanding, is strictly limited, by virtue of these articles to African Americans and/or designated minorities as defined by the United States government or the State of Florida government. This corporate entity is an effort to provide needed legally guaranteed minority participation, in various capitalistic and/or governmental ventures and not to wrongfully discriminate against any class of people.

# ARTICLE IV. TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing upon the filing of these articles with the Secretary of State for the State of Florida.

# ARTICLE V. INITIAL REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The Registered Agent and the street address of the initial Registered Office of this Corporation in the State of Florida shall be:
