Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned, Intelligent Systems M.D., Inc., a Florida corporation, by its President, does hereby make and execute these Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Intelligent Systems M.D., Inc.
2. The text of the amendment adopted is as follows:

RESOLVED, that the Articles of Incorporation of this corporation be amended by deleting ARTICLE V thereof in its entirety and by inserting, in lieu thereof, the following new ARTICLE V:

ARTICLE V  
Capital Stock

The aggregate number of shares which the corporation shall have authority to issue is one hundred million (100,000,000) shares of common stock, \$.01 par value per share.

FURTHER RESOLVED, that upon effectiveness of the foregoing amendment each of the issued and outstanding shares of the corporation's common stock be automatically converted, without any action on the part of the holders thereof, into 100 shares of common stock, \$.01 par value per share, of the corporation.

3. The date of the adoption of the amendment by the shareholders of the corporation was September 25, 2000.
4. The number of votes cast for approval of the amendment by the shareholders was sufficient for approval.
