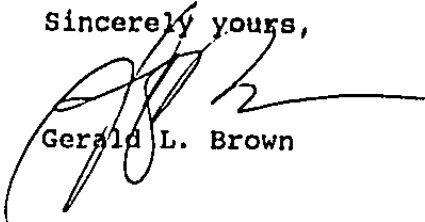

ARTICLE ONE - NAME

The name of the corporation is TIRES, INC.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.
