Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Medical Store I.V., Inc.
2. Article I of the Articles of Incorporation of the corporation is amended and restated in its entirety to read as follows:

ARTICLE I

The name of the corporation shall be Total Medical Solutions I.V., Inc.

3.
