## RICKY'S DOOR, INC.

We, the undersigned, desiring to form a corporation under the provisions of the Laws of the State of Florida, hereby make, subscribe and acknowledge before a Notary Public, and file with the Secretary of State of the State of Florida, Articles of Incorporation, as follows:

I.

The name of the proposed corporation shall be: RICKY'S DOOR, INC.

II.

The general nature of the business and the object and purposes proposed to be transacted and carried on, are to do any and all things hereinafter mentioned, as fully and as to the same extent as natural persons might or could do, viz: TO INSTALL AND REPAIR ELECTRONIC DOORS, to BUY, SELL AND SERVICE ALL ELECTRONIC DOORS.

A. The corporation shall engage in any activity or business permitted under the laws of the United States of America and the State of Florida.-
