ARTICLE I

The name of the Corporation is Cee Bee's Grove, Inc.

ARTICLE II

The Articles of Incorporation were filed effective as of March 22, 1996, and the Corporation was assigned document number P96000027451.

ARTICLE III

The Corporation's voluntary dissolution with the Florida Department of State Division of Corporations shall be effective as of the date the Articles of Dissolution are filed with the Secretary of State of the State of Florida (the "**Effective Date**").

ARTICLE IV

The voluntary dissolution of the Corporation was authorized by written consent executed on March 12, 2022 by all of its Shareholders and all of its Board of Directors who were entitled to vote. The President of the Corporation has the authority to wind up the Corporation's activities and affairs.

ARTICLE V

All debts, obligations, and liabilities of the Corporation have been paid or discharged.

ARTICLE VI

The President of the Corporation can execute instruments conveying any remaining property and assets of the Corporation to its Shareholders in accordance with their respective rights and interests.

ARTICLE VII

There are no suits pending against the Corporation in any court.




