Please be advised that the undersigned attorney represents *K R VENDING, INC.*, a Florida corporation. I have been directed by my client to contact you with the enclosed document, for the following reason:

My client is hereby filing the 1998 Annual Report on a "blank" form that was received after we noted that the preprinted form had not been received—and to this date, has not been received. Apparently, there has been a "mistake" in the computerized mailing address, and the preprinted materials are no being delivered. Please note, in the computerized history of the corporation, that the mailing address appears as "0931" under the street address. That is a mistake—it should be "OS31" or "Ocean Suite 31". 
