ARTICLES OF INCORPORATION

OF

HAPP'S REDWING RESTAURANT , INC.

ARTICLE - NAME

The name of this corporation is HAPP'S REDWING RESTAURANT, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK
