## ARTICLES OF INCORPORATION OF EXTEND A SHADE, INC.

Article I. Name.

The name of this corporation is EXTEND A SHADE, INC. It's address is 701 W. Jefferson, Brooksville, FL 34601.

Article II.

This corporation is organized for the purpose of transacting any or all lawful business.

#### Article III. Capital Stock.

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

### Article IV. Preemptive Rights.
