The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a professional association under the laws of the State of Florida pursuant to the provisions of Chapter 621, Florida Statutes, otherwise known as the "Professional Service Corporation Act" of the State of Florida, and Part II, Chapter 607, Florida Statutes.

ARTICLE I. - NAME

The name of this corporation is
LAW OFFICES OF MICHAEL J. McNICHOLAS
PROFESSIONAL ASSOCIATION

ARTICLE II. - NATURE OF BUSINESS

The corporation may engage in the practice of law which is permitted under the laws of the United States and of the State of Florida; to engage in any activities which will facilitate and promote the practice of law through its officers and employees; and to invest and reinvest its funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Section 621.08 of the Professional Service Corporation Act; and to purchase and own real and personal property necessary for the rendering of professional services within the practice of law. This corporation shall not be authorized to engage in any business other than the practice of law.

ARTICLE III. - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000.00 shares of common stock with a par value of One (\$1.00) Dollar per share. The consideration to be paid for each share shall be fixed by the Board of Directors. The stock so issued shall be fully paid and non-assessable.

ARTICLE IV. - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is FIVE HUNDRED (\$500.00) DOLLARS.

ARTICLE V. - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. - PRINCIPAL OFFICE

The initial street address of the principal office of this corporation in the State of Florida is 900 S. Federal Highway, 1st Floor, Stuart, Florida 34995.

The Board of Directors may, from time to time, move the principal office to another location in the State of Florida.

ARTICLE VII. - DIRECTORS

This corporation shall have not less than one director.

ARTICLE VIII. - INITIAL DIRECTORS

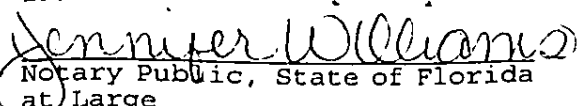

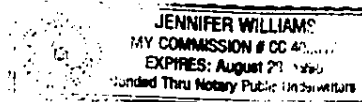
