The name of this Corporation is: OCEAN STATE DEVELOPERS OF JACKSONVILLE, INC.

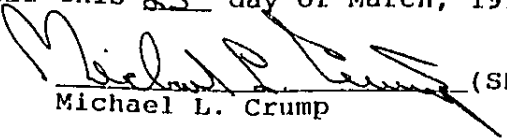

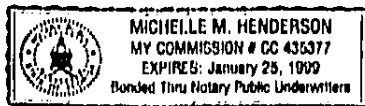

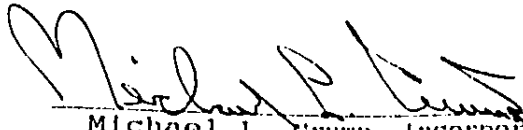
