BY THESE ARTICLES the incorporator forms a corporation under the Business Corporations Act:

1. NAME. The name of this corporation is VALCO OF SARASOTA, INC.
2. PRINCIPAL OFFICE. The address of the principal office of this corporation is 4733 Trails Drive, Sarasota, Florida 34232 and its mailing address is the same.
