

ARTICLES OF INCORPORATION

OF

THE NEW HOME SOURCE, INC.

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

- 1. The name of the corporation is THE NEW HOME SOURCE, INC. (the "Corporation").
