Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is PHYSICAL MEDICINE CONSULTANTS, INC. (the "Corporation").
2. The principal office of the Corporation is 7301 S.W. 97th Avenue, Miami, Florida 33173.
3. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of Common Stock, par value \$1.00 per share.
4. The street address of the initial registered office of this Corporation is 7301 S.W. 97th Avenue, Miami, Florida 33173, and the name of the initial registered agent of this Corporation at that address is Rafael P. Rey.

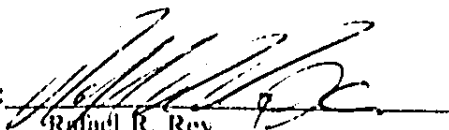
