STATE OF FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation to be effective upon filing.

ARTICLE I NAME

The name of the company shall be: LOTUS FINE CLEANERS AND LAUNDREERS, INC.

ARTICLE II PURPOSE

The purpose of the corporation shall be to conduct any business permitted under the laws of the state of Florida, without limiting such business operations to the state of Florida.

ARTICLE III PRINCIPAL OFFICE

ARTICLE IV CAPITAL STOCK



Such notification shall contain the following: (A) name and address of the proposed nominee (s), (B) principal occupation of the proposed nominee, (C) total number of shares to be voted for the proposed nominee, (D) the name and address of the shareholder submitting the nomination, (E) total number of shares owned by the shareholder submitting the nomination.
