ARTICLES OF INCORPORATION

OF

KEYFLEX, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is KEYFLEX, INC., (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION
