# ARTICLES OF INCORPORATION

OF.

# CARTER AND DAVIS, INC.

The undersigned subscriber to those Articles of Incorporation, being a natural person competent to contract, hereby form a corporation for profit under the Florida General Corporation Act under the laws of the State of Florida.

# ARTICLE I - NAME OF CORPORATION

The name of this corporation is: CARTER AND DAVIS, INC.

# ARTICLE II - GENERAL NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, State of Florida, or any other state, country, territory or nation.

# ARTICLE III - CAPITAL STOCK

The aggregate number of shares of capital stock authorized to Α. be issued by this corporation shall be 7,500 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The date when corporate existence shall begin is as of the date of execution of these Articles of Incorporation by the subscribers, and the corporation shall exist perpetually thereafter unless dissolved by law.

### ARTICLE V - ADDRESS OF CORPORATION

The initial street address of the principal office of this corporation in the State of Florida will be 2684 Windsong Circle, Palm Harbor, Florida 34684. The Board of Directors shall have the power to establish branch offices, and to move the principal office to any other address in Florida.

#### ARTICLE VI - BOARD OF DIRECTORS

- A. The initial number of Directors of this corporation shall be two (2). The number of Directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one (1).

#### ARTICLE VIII - BY-LAWS

- A. 
