ARTICLES OF INCORPORATION

OF

TALLA DELLA CORIDA

We, the undersigned, have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Flor'da relating to private corporations, and to that end do hereby adopt articles of incorporation as follows:

ARTICLET

Name

The name of the corporation is Electric Environmental Development, Inc.

ARTICLE II

Location

The principal office of the corporation is to be located at 4014 Gunn Hwy #275, Tampa, FL 33624.

ARTICLE III

Registered Agent

ARTICLES IV

Purpose

The purpose for which the corporation is organized is to engage in any lawful business activity.

ARTICLEY

Authorized Capital Stock

CAPITALIZATION:

Common Stock

The Corporation is authorized to issue 100,000,000 shares of preferred stock, par value \$0.001 per share.

Preferred Stock

The Corporation is authorized to issue up to 10,000,000 share of preferred stock, par value \$0,001 per share in one or more series, with suck voting powers, or without voting powers, and with such designations, preferences and relative, participating, optional or other special rights, and qualifications, limitations or restrictions, as shall be set forth in resolutions providing for the issue thereof adopted by the Board of Directors.

ARTICLE VI

Assessment of Stock

The capital stock of the corporation, after the amount of the subscriptions price or par value has been paid in, shall not be subject to pay debts of the corporation, and no paid up stock and no stock issued as fully paid up shall ever be assessable or assessed.

ARTICLE VII

Director Liability

A director of the corporation shall not be personally liable to the corporation or its shareholders for monetary damages for conduct as a director, except for liability of the director for (i) acts or omissions that involve intentional misconduct or a knowing violation of law by the director, (ii) conduct which violates state law pertaining to unpermitted distributions to shareholders or loans to directors, or (iii) any transaction from which the director will personally receive a benefit in money, property, or services to which the director is not legally entitled.

ARTICLE VIII

Indemnification

The corporation shall indemnity its directors against all liability, damage, or expense resulting from the fact that such person is or was a director, to the maximum extent and under all circumstances permitted by law; except that the corporation shall not indemnity a director against liability, damage, or expense resulting from the director's gross negligence.

ARTICLE IX

Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation in any manner now or hereafter permitted by statute. All rights of shareholders of the corporation and all powers of directors of the corporation are granted subject to this reservation.

ARTICLE X

Initial Directors

The members of the governing board of the corporation shall be styled directors. The initial Board of Directors of this corporation consists of three (3) directors. The names and addresses of such directors are as follows:
