ARTICLES OF INCORPORATION OF LAKSHMI, INC.

The undersigned incorporator, for the purpose of Printing a state corporation under the Florida Business Corporation Act, hereby after adopte the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION
