Article 1

Name. The name of this Corporation is InfoBack Corporation

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 2809 S.E. 17th Street, Ocala, 34471, County of Marion, State of Florida

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.
