The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation shall be: **NORDON DEVELOPMENT CORP., INC.**

ARTICLE II

ADDRESS

The address of the principal office of the Corporation is 6960 S.W. 1st Lane, Ocala, Florida, and the mailing address of the Corporation is Post Office Box 770120, Ocala, FL 32677-0120.

ARTICLE III

EXISTENCE OF CORPORATION

This Corporation shall have perpetual existence.

ARTICLE IV

BUSINESS, OBJECTS OR PURPOSE

The general nature of the business to be transacted by this Corporation or the objects or purposes of the Corporation shall be as follows:

1. To engage in and transact any lawful business for which corporation may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida. No other purpose limits this general purpose in any way.

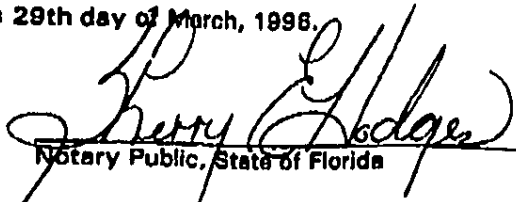
