

NAME

The name of this corporation is: Video/Web Markets, Inc.

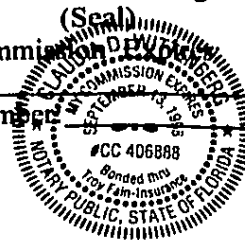


