ARTICLES OF INCORPORATION  
OF

made.

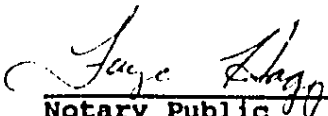

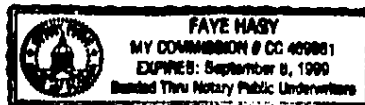
