ARTICLE I - NAME

The name of this corporation is Law Offices of Frank & Frank, P.A.

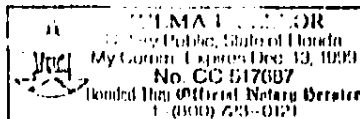
