ARTICLE I

Nama

The name of this Corporation is BOTTARY & PARTNERS PUBLIC RELATIONS, INC.

ARTICLE II

Principal Office

The principal office of this corporation shall be 200 West Forsyth Street, Suite 800, Jacksonville, Florida 32202,

ARTICLE III

Duration

This corporation shall have perpetual existence.

ARTICLE IV

<u>Purpose</u>
