### ARTICLES OF INCORPORATION OF ALL COMMUNICATION RENTALS, INC.

#### ARTICLE J - NAME

The name of this Corporation is:

ALL COMMUNICATION RENTALS, INC.

Its business shall be carried on in the State of Florida, in the United States of America and elsewhere, as may be authorized by its Board of Directors.

#### ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation shall be: the leasing and rentals of communication equipment including, but not limited to cellular phones, radios, fax machines and copy machines.
