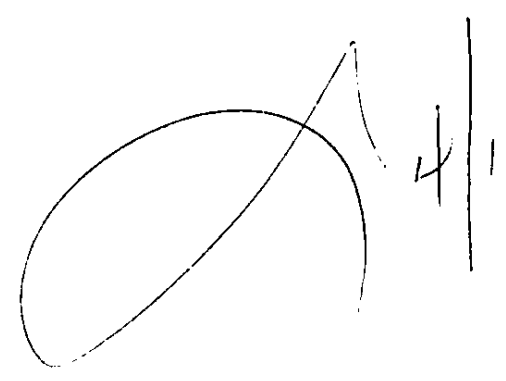

ARTICLES OF INCORPORATION
OF

JORDANVALE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is JORDANVALE, INC.

ARTICLE II
