The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

ARTICLE II - MAILING ADDRESS AND PRINCIPAL OFFICE

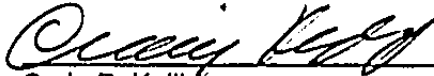

Pursuant to the provisions of Sections 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: NIDIA IGLESIAS, M.D. AND YOLANGEL HERNANDEZ SUAREZ, M.D., INC.
