ARTICLE I - NAME

The name of this corporation is HILL'S VAN SERVICE OF FLORIDA, INC.

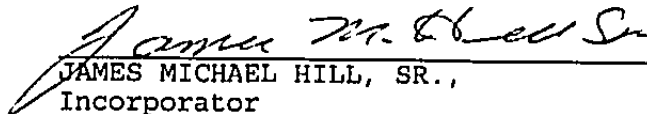
