

ARTICLE I - NAME

The name of this corporation is HILL'S VAN SERVICE OF FLORIDA, INC.

ARTICLE II - INITIAL PRINCIPAL OFFICE

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of NO par value common stock, all of which shall be of a single class.
